- 3. This Income Certificate shall be used only for educational purpose (for getting scholarship, merit award etc). Income Certificate for scholarship purpose may be issued within 3(three) days from the date of receipt of application. Specimen copies of Income Certificate, Student's undertaking for scholarship purpose are attached with this circular.
